Please ensure you have read the "Weddings at St Michael's" Information Booklet before completing this form. **This form must be completed and returned to the email addresses above at least 30 days before your wedding date. If you have any queries about music selection please contact the Music Manager, Rhys Boak, on Rhys.Boak@stmichaels.org.au Otherwise, the Standard Wedding Music Package will apply.** We recommend submitting your form as soon as possible.

Note: Your music selection form of recorded music, lyrics and the CD/USB must be provided at least 30 days prior to your wedding date to enable St Michael's to evaluate the suitability of that music and approval by the Music Manager. Please also include the complete lyrics of the songs proposed. Couples will need to ensure the CD or USB is also brought to the rehearsal and the wedding. (As added surety a backup copy of the music should be given to an attendee of your wedding.)

St Michael's allows the use of other musicians/vocalists and recorded music in CD or USB format. CDs and USBs can only be used for the Processional, during the signing of the register and the Recessional. If you wish to have other musicians/vocalists or recorded music during your service please complete the Wedding Music Selection form indicating your preferences.

Formatting requirements for CD and USB listed below are:

DVD PLAYER

All DVD discs including music burnt to DVD for longer playlists

MUSIC CDs

Burnt cd+, cd- and cd-rw discs

Mp3

WAV files burnt to cd

USB THUMB DRIVE

WAV

Mp3

Note: USB thumb drive MUST be formatted using FAT 32 before music is moved on to the drive.

Guidelines for Appropriate Recorded Music

St Michael's considers that music selection to be inappropriate if:

- Lyrics containing irreligious, blasphemous, racist, sexist, profane and indecent language are not acceptable
- Lyrics generally not in line with acceptable community standards (e.g. Lyrics condoning drug use or self harm, etc)
- Music that mocks Christianity

Guidelines for Additional Musicians/Vocalists

If you are considering additional musicians/vocalists, you must contact the Music Manager for approval **at least 30 DAYS PRIOR to your wedding date.**

The Music Selection Form must be submitted to the Music Manager and Administration Staff to the email above, at least 30 days prior to your wedding. If it is not received in this time frame, the Standard Wedding Music Package will be selected on your behalf and played on your wedding day. We recommend submitting your form as soon as possible.

If there are any technical difficulties on the day, the Organist will play the Standard Wedding Music Package.
