



**CHURCH COUNCIL UPDATE

Council approves the appointment of a Pastor

At its December meeting, the Council agreed to appoint a Pastor to work with our minister, Rev Dr Margaret Mayman, in a ministry team.

A Pastor is a recognised lay ministry of the Uniting Church. A person is designated as a Pastor for the exercise of ministry in a particular setting, e.g. congregation, chaplaincy, or church agency. This is different to Minister of the Word which is a nationally recognised “transferable” ministry. However, an ordained minister may apply for a pastor position.

Over the past two and a half years we have developed our Mission and Vision, Strategic Directions and comprehensive Mission Goals. New things are happening. We want to maintain the momentum, but to do this it has become clear that we need another person in our ministry team to work with Margaret and the Council.

The position description that the Council approved has a focus on two areas:

- assisting in leadership of worship
- supporting pastoral care and community life

Margaret will continue to have primary responsibility for ministry. This appointment will enable her to progress St Michael's goals of increased engagement with the wider community, and strategic leadership of the church's revitalisation project. The Council recognises the need to make her workload more sustainable.

Before a Pastor can be appointed, the Presbytery reviews the Position Description and decides whether to designate the position as appropriate for the ministry of Pastor. The PD was sent to Presbytery in late January. We will update the congregation as it progresses.

New Council Members

The Council was pleased to welcome newly elected members Chris Phillips and Jess Hand. Jess and Chris have already made valuable contributions to the life of our congregation. Jess is a member Environmental Working Group which developed the environmental action plan recently adopted by Council. Chris is a valued member of the First Aid Team. Both Chris and Jess are members of the Open and Affirming Working Group. We look forward to their governance contributions on Council.

Administration Officer

St Michael's members are Margaret Mayman (chair), Peter Anderson, Laura Beckett and Brian Smith, and Glen Tonkes (ex-officio), with Maree McDonald as an alternate. The PCG will meet monthly and report to Council.

In addition to Council members, the PCG also includes two representatives of Synod Property Services and two Presbytery members.

Finance

The treasurer reported that the draft Income and Expenditure Report for 2022 was showing a break-even result.

Planning Day

Council will meet for a planning session on Saturday February 4. Jac Tomlins will present a workshop to support Council's implementation of the Open and Affirming Project. Council will also focus on prioritizing actions needed to implement our Mission Goals.
