# **Anthony Bendall**

#### **CHURCH COUNCIL GOVERNANCE RESPONSIBILITIES**

I am an Australian lawyer, and eligible for an unrestricted practising certificate in Victoria.

I have held a number of relevant professional and volunteer positions with regards to governance. I commence this week at the National Transport Commission, as Principal Policy Officer – Legislation. In that role, I will provide legal and policy advice to the Commissioner and to the national meeting of Transport Ministers, to preserve and progress national transport law and policy. I will manage a small team of legal and policy experts.

I most recently backfilled the role of Manager, Regulatory Policy, the Health Protection Branch of the Department of Health, on a short-term basis. This involved leading a small team that provides legislative and regulatory advice to the Chief Health Officer and other senior executives on public health issues in Victoria, including the drafting of public health orders.

From March 2012 to April 2013, I was the Acting Victorian Privacy Commissioner. In this capacity, I was the sole agency head and responsible for all legal, policy, financial, management, staffing and governance decisions of the agency. The Victorian Privacy Commissioner was a separate employer under Victorian legislation and had the status of a government department. In addition, I have a long history of membership of boards and management committees, including Living Positive Victoria, the Victorian Pride Lobby, Liberty Victoria, Australian Lawyers for Human Rights, JOY 94.9 and community legal centres.

#### SPECIFIC SKILLS AND ATTRIBUTES OF CHURCH COUNCILLOR

As detailed above, I have extensive experience and skills in management and leadership.

I have an honours degree in Arts [BA Hons], a degree in Law [LLB] and a Doctor of Juridical Studies (SJD), all from the University of Sydney. I am an Australian Lawyer, admitted to the Supreme Court of NSW and the High Court of Australia and eligible for an unrestricted practising certificate.

I speak and write well. I have communicated and consulted with Ministers, their offices, members of Parliament, senior public servants, industry leaders, the judiciary, academics, people from diverse cultural and ethnic backgrounds, First Nations peoples and the media. I have given speeches and presentations at national and international conferences and seminars. I have frequently appeared before parliamentary committees and as an advocate in courts and tribunals. I have also written a wide variety of documents, requiring a clear style and ability to communicate with diverse audiences. These include legal advice, policy papers, submissions, speeches, Ministerial briefs and guidance materials for the community, industry, and government. I previously wrote a regular column in the Star Observer, a weekly LGBTIQA+ community newspaper. I also write and present news bulletins at JOY 94.9, a Melbourne LGBTIQA+ community radio station.

I am a trained and experienced mediator and conciliator.

#### **VOLUNTEER ROLES AT ST MICHAEL'S UNITING CHURCH**

My most recent church volunteer experience is as a Reader at St Michael's.

I also have a long history of volunteer work within the Catholic church, in which I was raised, mostly at St Patrick's Cathedral parish in Parramatta, NSW. This ranged from being an altar boy in primary school, a member of St Patrick's choir, a reader, an outreach volunteer for the Society of St Vincent de Paul, a teacher of Catholic catechism at government primary schools, to membership of the Bishop of Parramatta's Committee for Justice and Peace.

My deep connection with the Catholic Church ended in my adult years, due to increasing concern and distress over the position of the Catholic church on the role of women, the rights and interests of the LGBTIQA+ people, the centralised power structure and in particular the woefully inadequate response to the systemic abuse of children and other vulnerable individuals.

#### **GENERAL STATEMENT**

As mentioned above, I experienced rejection by, and consequently towards, my original faith of Catholicism as I developed through my adult years.

As I revealed in my St Michael's Day reflection last year, I also experienced something of 'a dark night of the soul', with issues of shame, depression, anxiety, substance abuse and addiction making my life increasingly unmanageable.

My first contact with St Michael's was some years ago, as Dr Francis Macnab's appearances in the media and discussion of the healing power of faith attracted me to his writings and to the Sunday gatherings. During that period, I also explored the writings of John Shelby Spong, Marcus Borg and several others.

While all of that held, my slide into chaos continued, culminating in a complete collapse during the lockdowns in 2020. I have subsequently discovered that my neurodiversity probably played a part in that , as I was diagnosed with ADHD and Autism Spectrum Disorder last year at the very ripe age of 57.

In that period, I discovered the Sunday gathering at St Michael's again, this time on YouTube. That, combined with my own reading and fairly intensive professional assistance led me to an inpatient rehab facility in NSW in late 2020 (as soon as the borders reopened) and to a deeper appreciation of progressive, contemplative Christianity.

This continues. I am about to enrol at the University of Divinity to study theology part-time in 2024. My fervent desire is to combine contemplation with action. Together with volunteer activities with Act for Peace, the World Council of Churches, Amnesty International and Fitzroy Legal Service, membership of the Church Council is a tangible way for me to embody and enact my rediscovered and revitalised faith.
